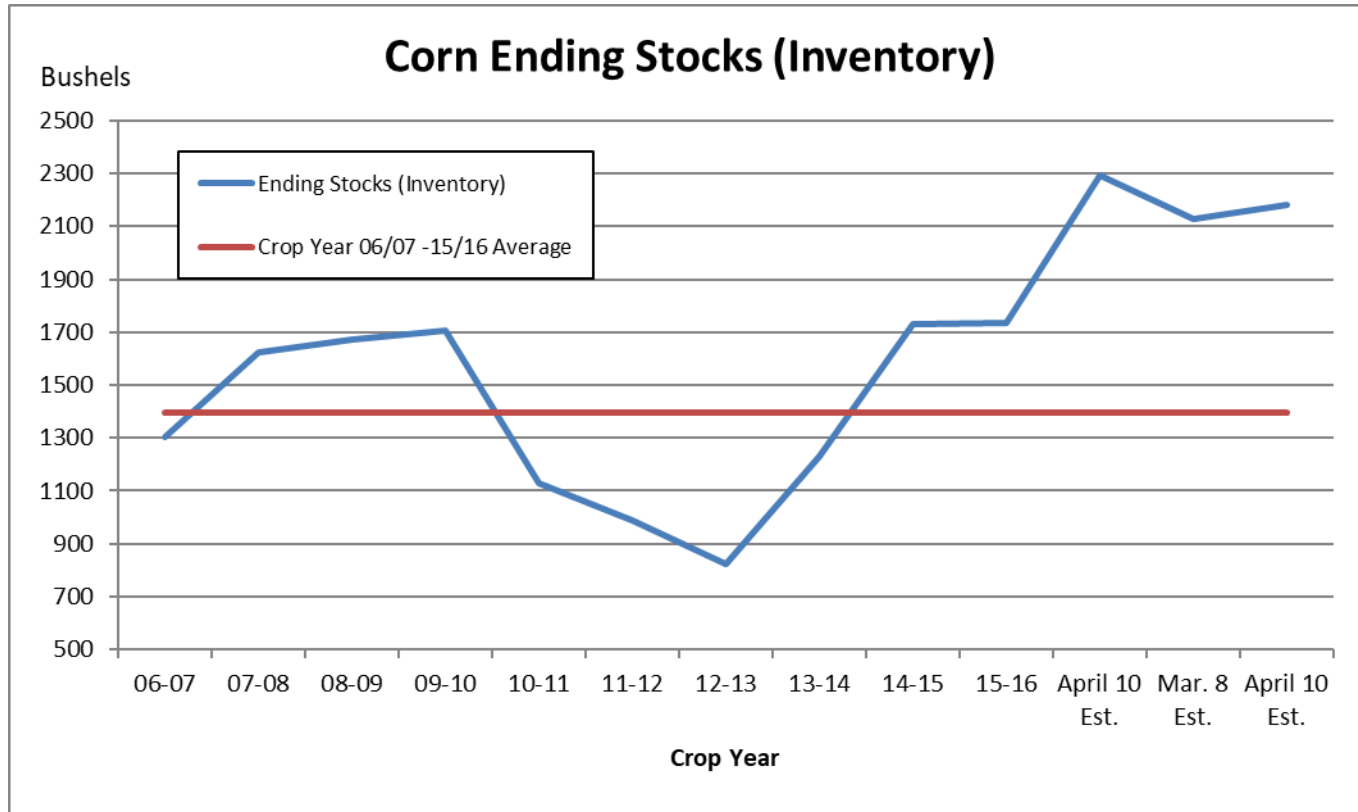

# U.S. Corn Ending Stocks (Inventory) Crop Year 2006-07 to 2017-18 Million Bushels

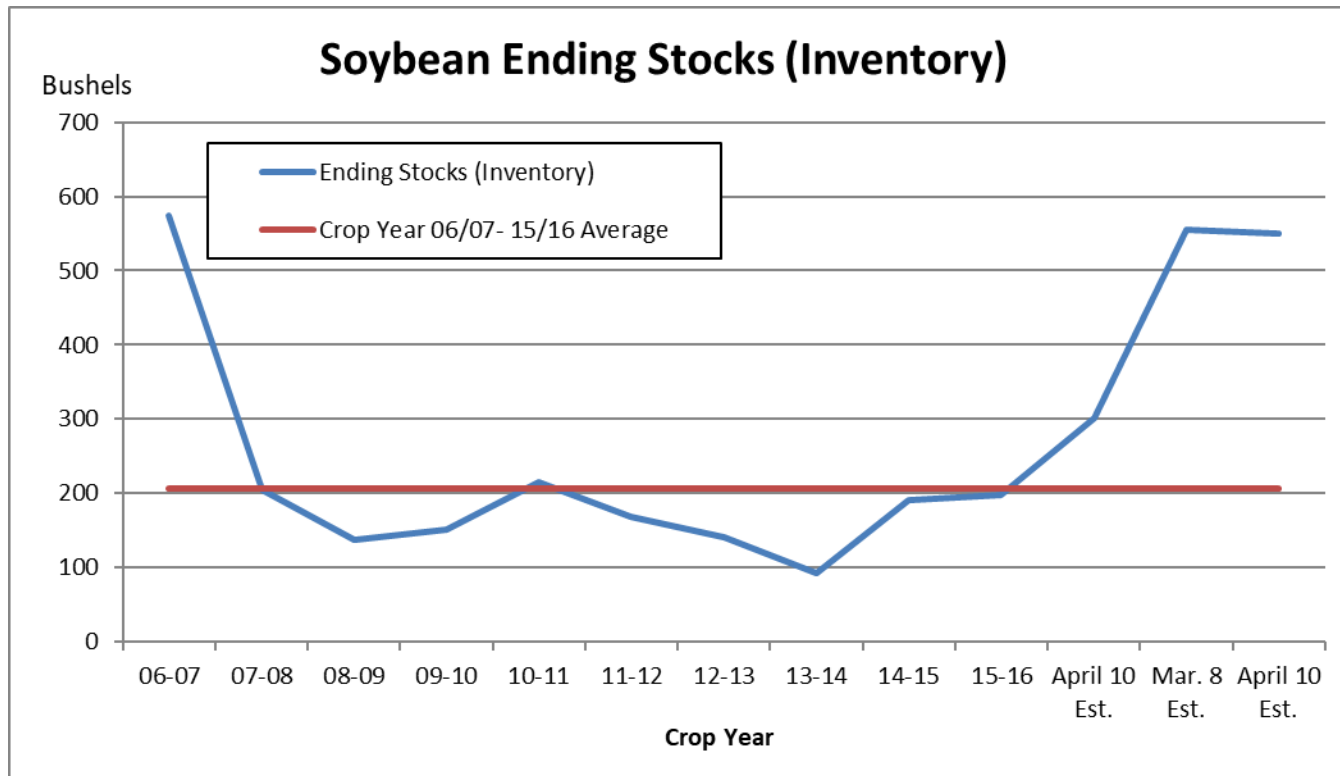

Million Bushels



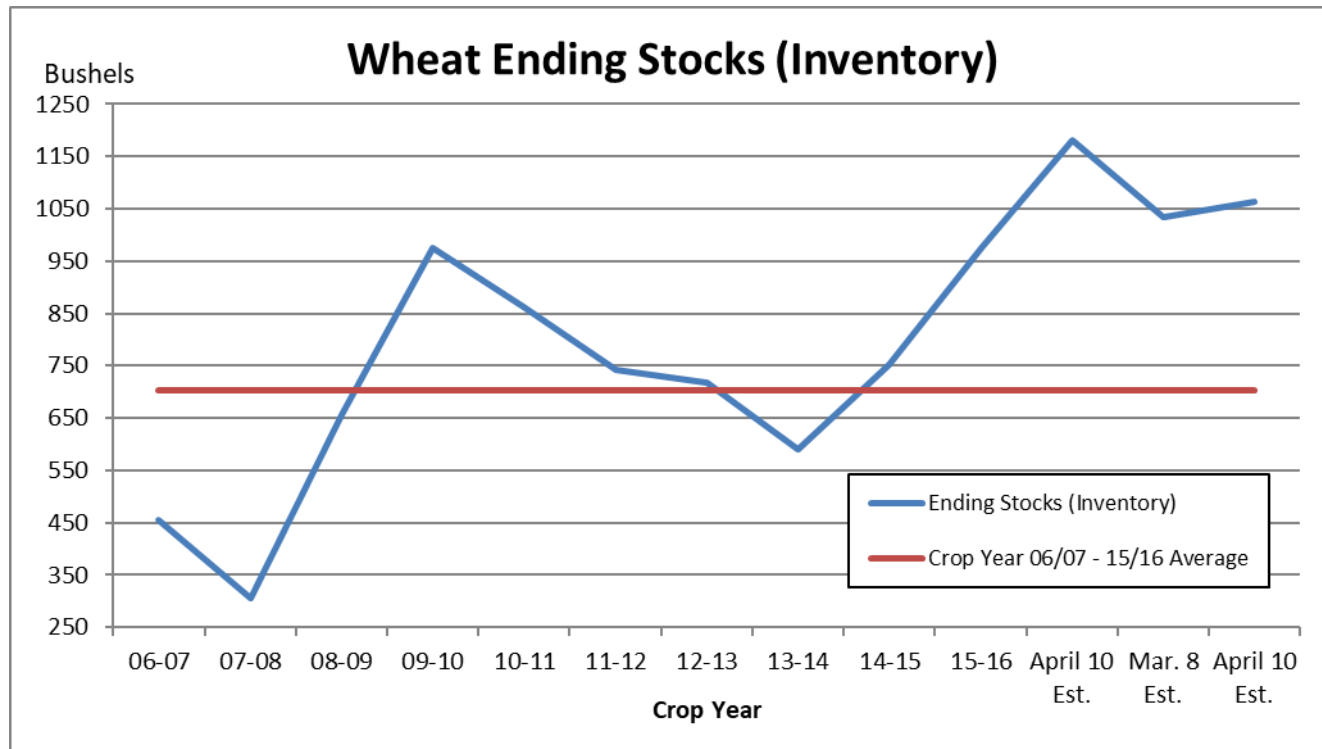
